NURSE CORPS SCHOLARSHIP PROGRAM

Awards funding for tuition, fees, and other educational costs to eligible nursing students, in exchange for working at a Critical Shortage Facility when you graduate for a specific amount of time.

MISSOURI COMMUNITY HEALTH FOUNDATION LOAN FORGIVENESS PROGRAM

Awards funding for tuition to eligible advanced practice nursing students as well as 3rd and 4th year Medical and Dental Students, in exchange for working at a Missouri Federally Qualified Health Center upon completion of training for a specific amount of time.

NHSC SCHOLARSHIP PROGRAM

Awards funding for tuition, fees, and monthly stipend to eligible advanced practice nursing, physician assistant, medical, and dental students who are pursuing a career in primary health care in exchange for practicing in defined areas of need upon graduation for a specific amount of time.

NHSC STUDENTS TO SERVICE (\$2S) LOAN REPAYMENT

Awards financial assistance to medical, dental, and advanced practice nursing students who are in their final year of school, in exchange for practicing in defined areas of need upon graduation for a specific amount of time.

MISSOURI COMMUNITY HEALTH FOUNDATION LOAN REPAYMENT PROGRAM

Awards financial assistance / loan repayment to apply towards education debt for primary care medical and dental residents, in exchange for working at a Missouri Federally Qualified Health Center upon completion of training for a specific amount of time.

FACULTY LOAN REPAYMENT PROGRAM

Repays a portion of your health professional student loan debt (\$40,000 max over two years). In return for service at an eligible health professions school.

NURSE FACULTY LOAN PROGRAM

Provides funding to accredited schools of nursing to establish and operate a student loan fund and provide loans to students enrolled in advanced nursing degree programs who are committed to becoming nurse faculty. In exchange for completion of up to 4- years of post-graduation full-time nurse faculty employment in an accredited school of nursing.

NURSE CORPS LOAN REPAYMENT PROGRAM

Awards loan repayment for Registered Nurses and Advanced Practice Registered Nurses working in a public or private eligible Critical Shortage Facility or Nurse Faculty employed at an eligible school of nursing, in exchange for a minimum 2-year service commitment.

MISSOURI STATE LOAN REPAYMENT PROGRAM

Awards loan repayment to licensed practicing psychiatry, primary care medical, and dental health professionals in exchange for services in Missouri areas with a shortage of mental health, medical, and dental professionals for a specific amount of time.

NHSC LOAN REPAYMENT PROGRAM

Awards loan repayment to primary medical, dental, mental and behavioral health care clinicians, in exchange for practicing in defined areas of need upon graduation for a specific amount of time.

NHSC SUBSTANCE USE DISORDER WORKFORCE LOAN REPAYMENT PROGRAM

Awards loan repayment to health care clinicians in exchange for serving at a NHSC-approved SUD treatment facility for a specific amount of time. Eligible clinicians include: Physicians, Nurse Practitioners, Certified Nurse Midwives, Physician Assistants, Behavioral Health Professionals, Substance Use Disorder Counselors, Registered Nurses, and Pharmacists.

NHSC RURAL COMMUNITY LOAN REPAYMENT PROGRAM

Awards loan repayment to support clinicians working to combat the opioid epidemic in rural communities in exchange for serving at a NHSC approved site for a specific amount of time. Eligible clinicians include: Physicians, Nurse Practitioners, Certified Nurse Midwives, Physician Assistants, Behavioral Health Professionals, Substance Use Disorder Counselors, Registered Nurses, Pharmacists, and Certified Registered Nurse Anesthetists.

SUBSTANCE USE DISORDER TREATMENT AND RECOVERY (STAR) LOAN REPAYMENT PROGRAM

Awards loan repayment for individuals working in SUD treatment jobs doing direct patient care in exchange for serving at an approved site for a specific amount of time. Many health provider disciplines and specialties are eligible including clinical support staff and behavioral health paraprofessionals.

HEALTH PROFESSIONAL LOAN REPAYMENT PROGRAM

Provides forgivable loans for the purpose of repaying existing educational related loans for health care, mental health, and public health professionals, in exchange for a 2-year service obligation in an underserved area.

PEDIATRIC SPECIALTY LOAN REPAYMENT PROGRAM

Offers loan repayment for eligible clinicians who provide pediatric medical subspecialty, pediatric surgical specialty, or child and adolescent behavioral health care services including substance use disorder (SUD) prevention and treatment services. Up to \$100,000 in repayment for eligible educational loans and 3 years of service at a qualified facility.

PUBLIC SERVICE LOAN FORGIVENESS PROGRAM (PSLF)

Forgives the remaining balance on your Direct Loans after you have made 120 qualifying monthly payments under a qualifying repayment plan while working full-time for a qualifying employer.
